THIS AGREEMENT, made the MAY 10 day of 2022, 2022, between **CITY GOVERNMENT OF BATAC** hereinafter called the "Entity" and **MEGAPOLITAN BUILDERS AND CONSTRUCTION SUPPLY** of **BRGY.48-B CABUNGAAN SOUTH, LAOAG CITY, ILOCOS NORTE** hereinafter called "Contractor".

WHEREAS, the Entity is desirous that the Contractor execute **CONCRETING OF FARM TO MARKET ROADS AT BARANGAY QUILING NORTE**, hereinafter called "the Works" and the Entity has accepted the Bid for **TWO MILLION THREE HUNDRED FIFTY-FOUR THOUSAND TWO HUNDRED SIXTY-EIGHT & 12/100 PESOS (Php2,354,268.12)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General and Filled in Special Conditions of Contract;
 - (b) Bidding Documents;
 - (c) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted;
 - (d) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (e) Eligibility requirements, documents and/or statements;
 - (f) Performance Security;
 - (g) Notice of Award of Contract and the Bidder's conforme thereto;
 - (h) Other contract documents that may require by existing laws and/or specified in the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
