 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the</u> <u>GPPB that are subsequently required for submission after the</u> <u>contract execution, such as the Notice to Proceed, Variation Orders,</u> <u>and Warranty Security, shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of FIVE MILLION THREE HUNDRED EIGHTY-NINE THOUSAND NINE HUNDRED SIXTY-TWO PESOS & 00/100 (PHP5,389,962.00) or such other sums as may be ascertained, ABM – A BUILDER MARKETING agrees for the PURCHASE OF VARIOUS MEDICINES AND VACCINES FOR THE CITY HEALTH OFFICE" in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
