- 3. In consideration for the sum of **TWO MILLION NINE HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED PESOS & 00/100 (PHP2,917,400.00)** or such other sums as may be ascertained, **NEW ERA VENTURES, INC.** agrees for the **PURCHASE OF 40 UNITS HAND TRACTOR** in accordance with his/her/its Bid.
