CONTRACT AGREEMENT

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the</u> <u>GPPB that are subsequently required for submission after the</u> <u>contract execution, such as the Notice to Proceed. Variation Orders.</u> <u>and Warranty Security, shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of Nine Hundred Ninety-Seven Thousand Nine Hundred Sixty-One Pesos & 00/100 (Php 997,961.00) or such other sums as may be ascertained, ABM-A BUILDER MARKETING agrees for the "PURCHASE OF MEDICAL, DENTAL & LABORATORY SUPPLIES" in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
