- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of SEVEN HUNDRED EIGHT THOUSAND SEVEN HUNDRED TWENTY PESOS & 00/100 (PHP708,720.00) or such other sums as may be ascertained, MSTRIT.COM COMPUTER MARKETING AND SERVICES agrees for the "PURCHASE OF LAPTOP COMPUTERS FOR USE OF VARIOUS OFFICES" in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
