- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of ONE MILLION NINE HUNDRED SEVENTY-SIX THOUSAND TWO HUNDRED EIGHTY PESOS & 00/100 (PHP1,976,280.00) or such other sums as may be ascertained, STY BATAC-AGRO INDUSTRIAL TRADING agrees for the PURCHASE OF PIGLETS, FEEDS, AND MEDICINES TO BE DISTRIBUTED TO SELECTED INDIGENT IN THE RURAL BARANGAYS IN THE CITY in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
