Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the</u> <u>GPPB that are subsequently required for submission after the</u> <u>contract execution, such as the Notice to Proceed, Variation Orders,</u> <u>and Warranty Security, shall likewise form part of the Contract.</u>

In consideration for the sum of FOUR HUNDRED SIXTY-SEVEN THOUSAND SEVEN HUNDRED PESOS & 00/100 (PHP467,700.00) or such other sums as may be ascertained, STY BATAC - AGRO INDUSTRIAL TRADING agrees for the "PURCHASE OF RABBIT (DOE AND BUCK), FEEDS AND VETERINARY MEDICINES TO BE DISTRIBUTED TO RABBIT RAISERS IN THE CITY" in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
