THIS AGREEMENT, made this 18 MAY 2023 day of _____, 2023, between the **CITY GOVERNMENT OF BATAAC** (hereinafter called the "Entity") and **MEGAPOLITAN BUILDERS AND CONSTRUCTION SUPPLY, BARANGAY 48-B CABUNGAAN SOUTH, LAOAG CITY, ILOCOS NORTE** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor "CONSTRUCTION OF SLOPE PROTECTION AND DRAINAGE SYSTEM ALONG THE GARBAGE POND AND CONCRETING OF ROAD NETWORK, #31 CAMANDINGAN, CITY OF BATAAC, ILOCOS NORTE" (hereinafter called "the Works") and the Entity has accepted the Bid for **SEVEN MILLION NINE HUNDRED NINETY-TWO THOUSAND TWO HUNDRED EIGHTY PESOS & 58/100 PESOS (Php 7,992,280.58)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General and Filled in Special Conditions of Contract;
 - (b) Bidding Documents;
 - (c) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted;
 - (d) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (e) Eligibility requirements, documents and/or statements;
 - (f) Performance Security;
 - (g) Notice of Award of Contract and the Bidder's conforme thereto;
 - (h) Other contract documents that may require by existing laws and/or specified in the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the works and to remedy defects therein conformity in all respects with the provisions of the Contract.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
