THIS AGREEMENT made this MAY 0 7 2024 between CITY GOVERNMENT OF BATAC, represented by ENGR. ALBERT D.  - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of ONE MILLION EIGHT HUNDRED EIGHTY-NINE THOUSAND TWO HUNDRED TEN & 00/100 PESOS (PHP1,898,210.00) or such other sums as may be ascertained, STY BATAC AGRO INDUSTRIAL TRADING agrees for the "PURCHASE OF HYBRID VEGETABLE SEEDS AND MATERIALS FOR DISTRIBUTION TO VEGETABLE GROWERS AND FOR GULAYAN SA BARANGAY" in accordance with his/her/its Bid.
- The CITY GOVERNMENT OF BATAC agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
