Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and



- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of NINE HUNDRED NINETY-THREE THOUSAND SEVEN HUNDRED FORTY-NINE & 12/100 PESOS (PHP993,749.12) or such other sums as may be ascertained, JAHDTIYAR ELECTRICAL AND INDUSTRIAL SUPPLIES TRADING agrees for the PURCHASE OF MATERIALS FOR THE PASILAW PRO-POOR PROGRAM in accordance with his/her/its Rid
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
