- 3. In consideration for the sum of NINETEEN MILLION NINE HUNDRED EIGHTY-FIVE THOUSAND FIVE HUNDRED & 00/100 PESOS (PHP19,985,500.00), or such other sums as may be ascertained, NEW ERA VENTURES, INC. agrees for the "PURCHASE OF 1000 UNITS WATER PUMP" in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
