In consideration for the sum of THREE MILLION FIVE HUNDRED FIFTY-FIVE THOUSAND FOUR HUNDRED EIGHTY & 00/100 PESOS (Php3,555,480.00) or such other sums as may be ascertained, ROLREN'S LANTERN AND GENERAL MERCHANDISE agrees for the "PURCHASE OF LIGHTS, DECORATIONS AND LANTERNS" in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
