WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "**PURCHASE OF WATER PUMP**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINETEEN MILLION NINE HUNDRED EIGHTY-FIVE THOUSAND FIVE HUNDRED & 00/100 PESOS (PHP19,985,500.00),** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the</u> <u>GPPB that are subsequently required for submission after the</u> <u>contract execution, such as the Notice to Proceed, Variation Orders,</u> <u>and Warranty Security, shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of NINETEEN MILLION NINE HUNDRED EIGHTY-FIVE THOUSAND FIVE HUNDRED & 00/100 PESOS (PHP19,985,500.00) or such other sums as may be ascertained, NEW ERA VENTURES, INC. agrees for the PURCHASE OF WATER PUMP in accordance with his/her/its Bid.
- 4. The **CITY GOVERNMENT OF BATAC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
